**Abstract** The Women and Girls Collective Action Network (WGCAN) was

established in Chicago, Illinois in August 2004 as an organization dedicated to ceasing violence and social injustices against women and girls. WGCAN provided training, resources and programs to

strengthen connections across communities and promote collective action.

The Women and Girls Collective Action Network records span from 2004-2011 and contain documents pertaining to the internal workings of the organization as well as material created for and during their public

projects and programs.

## Biographical/Historical note

The Women and Girls Collective Action Network (WGCAN) was established in Chicago, Illinois in August 2004 as an organization dedicated to ceasing violence and social injustices against women and girls. Over time, the organization broadened its reach, serving as a community center that combined individual transformation and self care with social activism. WGCAN provided training, resources and programs to strengthen connections across communities and promote collective action. In 2005, WGCAN launched its first initiative, Females United For Action (FUFA), a female-led coalition that focused on healing, consciousness-raising, and transformative social change. WCGAN helped release two analytical reports, Communities Engaged in Resisting Violence (2007), and Status of Girls in Illinois (2009). From 2004-2010, Melissa Spatz served as WGCAN's founding Executive Director. The organization closed in 2011.

## **Scope and Contents note**

The Women and Girls Collective Action Network records span from 2004-2011 and contain documents pertaining to the internal workings of the organization as well as material created for and during their public projects and programs. Documents include meeting minutes, correspondence, flyers, research, workshop exercises, statistical reports and surveys. The records also include a collection of photographs from "Alternative Windows," a Females United For Action (FUFA) project that exhibited photographs taken by local teenagers depicting positive images of women. The records are arranged into two series, "Administrative" and "Programs."

#### **Scope and Contents note**
